BVA President Reviews 27th Remembrance

Another year of waiting has come and gone for all us who were able to attend the Beirut Remembrance ceremony and now we wait for next year.

For all who were able to travel and attend, I would like to thank you. I know that taking the time to attend is hard in many ways for different reasons for each of us. For me, I gain so much more and take home with me new friendships, experiences and memories.

As President of the BVA, I thank all of you who have taken it upon yourselves to arrange and plan these ceremonies across the nation. Because of you, many Beirut vets and families are now able to attend a ceremony closer to home and attend for other reasons. Because of you Beirut Vets and family members are being found; because of you and the ones who attend, you have reminded the people of this Nation, "The First Duty is To Remember."

In Jacksonville, NC this October we had about 100 people attend the event there. As with every year, Oct, 22nd started off with registering at the USO and meeting up with families and friends. At 3 p.m. we held our BVA annual meeting. Below is a rough outline of the meeting.

Mike Miller and Sarah Holcomb, Archives & Special Collections, Library of the Marine Corps, Marine Corps University, Quantico, VA (2040 Broadway St., Quantico, VA 22134, (703) 784-4685) told us they are still looking for stories, pictures, artifacts and materials of interest to help them in their endeavor to tell our story for generations to come.

Deborah Fisher, Interim Director, USO of North Carolina, Jacksonville Center, introduced herself and her staff and thanked the BVA for using the USO. She informed us of the remodeling the USO was doing to the Beirut Room (which should be done by the time you read this). Lowe's Home Improvement and Freedom Furniture are donating materials and furniture, plus employees are also volunteering their time to rebuild and remodel the room. They are asking for Beirut vets and family members to be there when they have the grand opening of the Beirut room Jan. 14th, **2-4 p.m.** This room was established around the 10th anniversary of the bombing. In it are some pictures of the men who gave their lives to tried to help establish peace in Beirut, Lebanon, along with other mementos, paintings and pictures.

What they would like is 5x7" pictures scanned to a computer so that they

Pearl Harbor, Beirut Bombing

Both were American Wakeup Calls

I had an OMG (Oh My God!) moment on Sunday, December 5th, that I think Beirut veterans and families might appreciate.

I was at a Pearl Harbor remembrance event sponsored by our local Dixie Wing of the Commemorative Air Force. I had the honor of talking with the only Pearl Harbor survivor in attendance, Mr. Roy Mooney. The other survivor who was scheduled to attend fell and broke his hip and couldn't make it.

As I asked Mr. Mooney question after question about his view of that Day of Infamy, I kept making mental correlations to it and the Beirut Day of Infamy, October 23,

Then Mr. Mooney said something that brought it all home.

He was telling me how he and his infantry unit had been put on full military alert an entire two weeks prior to the sneak attack on Dec. 7, 1941. He said they were guarding fighter aircraft at Wheeler Airfield, about a mile from their quarters at Schofield Barracks until the afternoon of December 6th, when they were relieved by another unit, sent back to their barracks, secured their weapons and ammo in the armory, paid their \$30 monthly salary and given liberty in Honolulu.


a.m. to get breakfast because, "If you didn't get it by 8, you didn't

eat," he recalled. ""We were eating and suddenly heard 'boom, boom, boom' as the Japs started bombing Wheeler Field."

He recounted how they ran outside to see the carnage a mile away. "If we had been allowed to keep our weapons and ammo we could have shot many of the enemy airplanes down, that's how low they were flying," he recounted as he fought to keep his voice steady and eyes free of tears. "That is why I continue to tell the story of what happened," the 87-year-old hero told me. "Somebody has got to continue telling the story or the American public will forget," he said.

That's when it struck me that these two sneak attacks, one in 1941 and one in 1983, were connected, if not by historical facts, then by the magnitude of their impact on the American consciousness. Pearl Harbor pulled the U.S. into WWII; The Beirut Bombing pulled us, unknowingly, into the Global War on Terror.

So if BVA members, families and friends ever question why we do what we do, you can quote a Pearl Harbor hero, Mr. Roy Mooney, "Because somebody has got to continue telling the story."

VOICES FROM BEIRUT: The Peacekeepers Speak

BVA Next of Kin members Mary Ellen Jackowski and Peggy Stelpflug plan to collaborate on a collection of letters from the Peacekeepers.

They would like family members and Beirut Vets to participate by submitting either one of their letters -- or excerpts from various letters -- written by the Beirut Peacekeepers.

Since memories fade, this will be a permanent record of the thoughts and feelings at that time.

"Though this process may open up painful memories, the desire to record the thoughts of the US Peacekeepers, 1982-1984, overcomes this very real concern, say the collection's compilers. "Those who died in Beirut can no longer speak for themselves, but we can be their voices and ensure that their words are heard.

Through this project, by sharing personal thoughts, Beirut Vets can continue their healing process."

If no letter from Beirut is available, a present-day written account regarding a particular serviceman can be submitted. This account may include any specific memory or experience such as why he joined the military, thoughts about the peace-keeping mission, future plans or any memory or experience shared during his time in Beirut.

The format of the collection will include an alphabetical listing of one page per serviceman:

Sgt. John S. Doe U.S. Marine Corps H&S 1/8 MOS: Cook An introductory paragraph about the serviceman; The letter or excerpts from several letters;

Your name and relationship to the serviceman which indicates your permission to publish the information.

Before the *Beirut Connection* became part of the BVA, many families and vets shared letters from Beirut. Permission to reprint any of those letters would be greatly appreciated. (Please follow the sample format.)

"I just got an email from Sgt. Tommy Keown's brother with his last letter from Beirut," said Mary Ellen. "I hope everyone will submit a letter. I feel strongly that if we don't do this project soon, no one will hear their 'voices."

This project was in the planning stages before the 25th Remembrance and it is our hope that it will be realized before the 30th Remembrance in 2013.

Dogs had founded the first monument at Camp Geiger then planned and performed a Beirut ceremony each year since the first anniversary of the bombing. He requested the BVA acknowledge them with a donation and a plaque. The members voted for a plaque and \$500 to be given.

USO: The members asked to give a donation to the USO for providing the building to the BVA each year. Kevin Krier stepped in and started walking around the room with a hat and donations quickly filled his cover. \$256 dollars was collected and with \$150 dollars collected from the raffle a total of \$406.00 was presented to the USO.

The meeting was adjourned.

That evening we all met up at the Holiday Inn Express and had a great time. Local business donated beverages and snacks, with some guys bringing in their own. The Holiday Inn gave us the lobby room to meet in, but most stayed outside where the weather was cool but great. I don't know what time the last few closed it down because I wimped out about 2130 hrs.

Saturday Oct. 23rd at 6 a.m. about 75 people gathered for our Candlelight ceremony at the Beirut Memorial. Major Bob Jordan asked DAV chaplain Bentley Black to open with a prayer and then he spoke of the sacrifices' that were made so that Beirut may be given the chance for peace. He recounted how the families have suffered and given more than most people will understand and about how this act of terrorism should be recognized as the first against this great Nation.

At the conclusion, family members and veterans began to read the names inscribed in the wall. At 6:22 a.m. the last name was read and Major Jordan asked that we all pause for a moment of silent prayer. Major Jordan then spoke a few words and asked Chaplain Black to close with prayer.

At 10:30 all gathered at the Beirut Memorial for the Remembrance ceremony hosted by the city of Jacksonville, NC. The 2nd Marine Division Band was on hand and the Brewster



Middle School Choir. About 500 people attended and the guest speaker was Lieutenant General Dennis Hejlik, commander, U.S. Marine Forces Command, who was a Captain with 2/8 in Beirut after the bombing.

He stepped up to the platform to deliver the speech he had written, paused for a moment and looked across the crowd and folded up the speech and said, "I came here today ready to deliver this speech, but I'm not going to read



this." Then he started to speak from his soul. In his words he told his story about the feelings he himself felt at hearing about the bombing of the battalion and how within a week he was there looking at the destroyed remains of the building.

There in and around the rubble he saw "memorials" the men of the 24th MAU had left and built in honor of the losses and memories of their brothers. He went on to say how that has stayed with him through these years and how it has guided him to where and what he is today.

His words, though unplanned, struck the heart of every veteran and family member there as I'm sure it was delivered from his own.

The end of the ceremony was performed with a precision that I have witnessed only a few times, by the Color Guard and rifle detail of 2/8. These young Marines were so sharp and in time that many in the crowd commented. I am very proud of them and honored that these Marines shared their day, this day, with us. To the city of Jacksonville and the Marines of 2/8....... Semper Fi and thank you.

With a few hours to burn before the next ceremony there was time to eat and go to the Exchange to browse and shop before we gathered again on Camp Geiger at 2 p.m. to attend the memorial services hosted by the Military Order of the Devil Dogs.

This ceremony has been running now since the first anniversary, making it the 26th. Although fewer people attend, it is the one I personally like attending the most other than the Candle Light. The service is of a smaller scale compared to the city's, which is only because those attending consist of family members and veterans and others who have personal reasons.

The guest speaker was Col Brown, Acting Chief of Staff for the 2nd Marine Division. At the conclusion, Rolling Thunder formed two lines and gave honor to the Beirut Veterans and the family members by honoring us and the memories of our brothers as we walked between the columns. Semper Fi and thank you Rolling Thunder and especially to the Military Order of the Devil Dogs.

Georgia Marines Hold 1st Beirut Memorial 5K

Marine Corps League Detachment 1339 in McDonough, Georgia held its first Beirut Memorial 5K Run on October 23, 2010.

At 5 p.m. on a sultry southern day, race organizer and Det. 1339's junior vice commandant, Jeff Owen, announced to the 200 runners the purpose of the run.

"As you run today remember those 220 Marines, 18 sailors and 3 soldiers who were killed on October 23, 1983 in the Beirut barracks bombing as today we honor them and the others killed in action in Beirut"

Owen also introduced BVA founding vice president Randy Gaddo and Beirut veteran Chuck Conkle who attended the event. Conkle, a scoutsniper, looking sharp in his dress blues, started the race.

"This was a very special tribute to our brothers killed in action in Beirut," said Gaddo. "The fact that this group of Marines chose the 23rd of October as the date of their race and recognized it as the date of the terrorist bombing validates the BVA's efforts in keeping the memory of our fallen heroes alive in the American con-

sciousness."

The BVA became a sponsor of the event by donating \$250 to the cause. Proceeds of the run will help support the Wounded Warrior Project and the Marine Corps Reserve Toys For Tots program.

The Beirut Memorial 5K is part of the Run & See Georgia Grand Prix series. It is intended to become an annual event.

Detachment #1339 of the MCL is commended for an outstanding effort. The young detachment was just formed in September of 2009 so it is an especially impressive feat to pull together an event of this size. Of special note is Jeff Owen's contribution, as this was the first run he had ever organized and he quickly learned there are many moving parts to such an initiative.

Later, at 1 p.m., a remembrance ceremony was held at the memorial. The Tri-County Marine Corps League presided over the event. Speakers included BVA members Donald (Gunny) Inns and Alan D. (Big Al) Opra, with keynote speaker Helen Montgomery. The event featured family members laying memorial wreaths escorted by **Beirut Marines and a Gunnery Sergeant** from the local recruiting office. The Marine Corps League rendered a rifle salute. **Struthers Mayor Terry Stocker commented** in his weekly report to the community that the service members killed in Beirut will never be forgotten.
