30th Remembrance Planning Accelerates

BVA Organizers Plan Dinner for 600+

BVA volunteers planning the 30th Beirut Remembrance scheduled for October 22 and 23 in Jacksonville, N.C. face a challenge as they prepare for anticipated record attendance this year.

On point in Jacksonville is newly-appointed BVA Vice President Dan Joy. He has been working with Jacksonville hotels, businesses, memorial committee members, Camp Lejeune officials and anyone else necessary to actualize the 30th Remembrance.

The biggest challenge has been finding a venue that can ac-



commodate the BVA dinner. Historically, every fifth year the BVA has hosted a dinner and program. At the 25th Remembrance in 2008 nearly 700 people were seated for the event.

"The only place we can find large enough to accommodate that many people is the Goettge Memorial field house on Camp Lejeune," said BVA President Craig Renshaw, who is a key planner for the event.


At press time organizers had already taken steps to secure the field house for the event.

Planners are looking for ways to streamline the event this year to reflect the small number of volunteers who spend a great deal of their own time planning this large event.

As President, Renshaw will be overall director for the event.
Alex Hacala, wife of immediate past chairman of the BVA board Mark Hacala, will coordinate with a caterer for the dinner and venue set-up. BVA founding vice president and Root Scoop II editor Randy Gaddo will develop the program and serve as the master of ceremonies.

Seeking Volunteers

Organizers are seeking volunteers who can assist with certain

As planning progresses, the BVA website, which is undergoing upgrades at press time, will be a primary method of passing information and enabling registration and dues payments.

The website address should remain the same: www.beirutveterans.org.

One of the challenges in the past associated with having events on base is getting smooth access onto base. Event attendees who do not have other access credentials such as vehicle base stickers or retired ID cards should plan additional time to obtain proper base passes.

"We will be working with base officials to try and work out the easiest possible access process for 30th Remembrance attendees," said Renshaw. "However, due to security restrictions there are certain procedures we are obligated to follow in accordance with what base officials will allow."

There will be a candlelight service at 6 a.m. on October 23 at the Beirut Memorial. This service is

for family members, fellow service men and women and friends, not the general public. At the service, each name on the Beirut wall is read aloud

The City of Jacksonville and Camp Lejeune will also hold the official public Remembrance at 10:30 on October 23. The dinner is also being planned for the evening of October 23 at Goettge field house.

If time and circumstances permit, planners are also considering events on October 22 that will give Remembrance attendees an opportunity to gather and socialize. One idea is to hold a formation, which was a popular event at the 25th Remembrance. "This will depend on whether we can get adequate numbers of volunteers to help organize it," said Renshaw.

The First Duty Is To Remember

Lawrence "Larry" Downs, Sr., 86, of Jacksonville, died Feb. 2, 2013 at Carebridge in Jacksonville, N.C. Many will remember Mr. Downs as the stalwart husband of Doris Downs, who pre-deceased him in June 2004 after a battle with cancer. Doris, with constant support from Larry, played a central role in planting the 241 Bradford pear trees along Lejeune Boulevard and later in founding the Beirut Memorial located at the entrance to Camp Johnson. She helped raise more than \$400,000 for the work. After the memorial was established, Downs continued her efforts by forming the Beirut Memorial Advisory

Board and establishing an annual observance on Oct. 23. Mr. and Mrs. Downs are greatly missed and the BVA sends condolences to their family.

At press time learned that BVA Founding President Bob Jordan's grand-nephew was KIA in January. Condolences to the family of PO1 Kevin Ebbert, 32, a Special Warfare Operator assigned to a Navy SEAL team in Afghanistan according to socnet.com.

VOICES FROM BEIRUT: The Peacekeepers Speak

Editor's Note: As we move toward the 30th Remembrance this year, it is especially important that families, friends and fellow service members make a special effort to support this monumental effort, "Voices From Beirut." This can be an enduring document to capture forever the words, thoughts and memories of those who died fighting the first battle in the Global War on Terror.

BVA Next of Kin members Mary Ellen Jackowski and Peggy Stelpflug are collaborating on a collection of letters from the Peacekeepers.

They would like family members and Beirut Vets to participate by submitting either one of their letters -- or excerpts from various letters -- written by the Beirut Peacekeepers.

Since memories fade, this will be a permanent record of the

thoughts and feelings at that time.

"Though this process may open up painful memories, the desire to record the thoughts of the US Peace-keepers, 1982-1984, overcomes this very real concern," said Mary Ellen. "Those who died in Beirut can no longer speak for themselves, but we can be their voices and ensure that their words are heard. Through this project, by sharing personal thoughts, Beirut Vets can continue their healing process."

If no letter from Beirut is available, a present-day written account regarding a particular serviceman can be submitted. This account may include any specific memory or experience such as why he joined the military, thoughts about the peace-keeping mission, future plans or any memory or experience shared during his time in Beirut.

The format of the collection will include an alphabetical listing of one page per serviceman:

Sgt. John S. Doe U.S. Marine Corps H&S 1/8 MOS: Cook

An introductory paragraph about the serviceman;

The letter or excerpts from several letters;

Your name and relationship to the serviceman which indicates your permission to publish the information.

Before the *Beirut Connection* became part of the BVA, many families and vets shared letters from Beirut. Permission to reprint any of those letters would be greatly appreciated. (Please follow the sample format.)

"I just got an email from Sgt.
Tommy Keown's brother with his
last letter from Beirut," said Mary
Ellen. "I hope everyone will submit
a letter. I feel strongly that if we
don't do this project soon, no one
will hear their 'voices.'

"This project was in the planning stages before the 25th Remembrance and it is our hope that it will be realized before the 30th Remembrance in 2013."

Example From Hukill Family Given To Help Others Contribute

EDITOR'S NOTE: BVA family members Mary Ellen Jackowski and Peggy Stelpflug have been working hard since before the 25th Remembrance in 2008 to get the word out about "Voices From Beirut." (See page 4 for details) They do have submissions trickling in, but not at the rate it should be. I cannot stress enough how very important this project is. The letters from our fallen brothers speaks volumes about what we did in Beirut and this will be an important document for researchers years from now, when they want to go back and find out what the troops were saying. The excerpts from Maury Hukill below provides one example of how it can be done. It is meant to encourage others to submit material. It can be entire letters, excerpts from letters or a written account of the serviceman from a family member. Maurice Edward Hukill, 2nd Lt., USMC (Maury)

3rd child of seven born to Capt. Henry D. Hukill (USN Ret.) & Virginia Ellen Hukill on Nov. 26, 1957 in South Bend, Indiana; Husband to college sweetheart, Mary Tony Hukill; Hometown: Jacksonville, N. C.; Graduated from Virginia Tech in May 1981 with a degree in Forestry & Wildlife Management; graduated from Officer Candidate School at Quantico, Va. Assigned to USMCR H&S CO BLT 1/8 24-MAU; KIA October 23, 1983, Beirut, Lebanon

May 23, 1983-Letter to Matt & Deb, brother & sister-in-law, from the USS Iwo Jima: We have a lot of briefs on the situation over there and I can say this. While we are here this thing is going to come to a head. We may just pull out or we may shoot the f--- out of some Syrians or PLO! Who knows? I carry a loaded 45 caliber and won't hesitate to shoot. ...I am the senior Engr. Commander. I have 40 men who work directly for me and our main mission is demolitions (TNT, C-4 which is plastic explosives etc...). I am also in charge of clearing all minefields etc...

June 1, 1983-Letter to Mom & Dad from BLT, Beirut:

I can't remember when I've worked this hard. The BLT (Battalion Landing Team) headquarters (which I am a part of) lives in a 4-story bombed out building which was burned twice. The electricity was rigged up by those who came before us. The power comes from a generator out back. I am responsible for several things some of which are, showers (hot), sewage removal, building bunkers, and digging trenches with very heavy equipment. Today I took a squad of my troops up to the new American Embassy. The security there is tight and we all carry live rounds. We are building bunkers and road blocks out there. The Embassy is in the heart of the city and when I go we have two Jeeps with 10 guards for security. The old embassy is only a block up the road and it is a mess. The Christian militia and Shiite Muslims fight all the time at night. We stand on top of our building and watch the 50 caliber machine guns and mortar rounds hit the city. They're not too close to us, but twice we took rounds in our area. All in all things are quite secure.

August 17, 1983-Letter to brother Monte from BLT, Beirut I am ok except for my ankle. I tore the ligaments playing basketball so I am in a cast for 4-6 weeks. Things are quiet here now and I hope they remain that way. Mark was in outer space one night and called me here through the American Embassy. What a trip!

Sept. 3, 1983-Letter to Mom & Dad from BLT, Beirut: Well, it did get pretty hairy around here for about 2 days. We

were taking a lot of small arms fire and artillery shelling. So after 2nd Lt. Losey and SSgt Ortega were killed, we finally got the okay to shoot back. So we opened up with M16 rifles and M60 machine guns. We only fire in self defense. Not to worry though. I am perfectly safe here and feel that way. My platoon was sent to the line companies for awhile to help support them. September 21, 1983-Letter to brother Mark from BLT: I guess you are keeping up with the news so you know we are taking quite a few rockets, mortars and artillery shells in our area. Well we finally decided to shut them up and in the last two nights we fired 280 rounds from the 8" guns on the USS John Rogers. Needless to say things are somewhat quieter now. We also had 2 A-6's and 2 A-7's take off from the "Ike" with 1 million dollars worth of 500 & 1000 pound bombs. Right before they were to drop them the mission was aborted. So needless to say no jets can land on the "Ike" with live rounds so they dumped all the bombs in the f---ing ocean. What a waste. Oh well, maybe we'll do it again tomorrow. P.S. The New Jersey is due to arrive tomorrow just in case the Syrians want to play

Sept. 22, 1983-Letter to Meredith & Ken, sister & brother-in -law, from BLT, Beirut: Lately we have been receiving artillery shells just about every day. We spend most of our time in the Basement and fox holes. To date we have had 4 KIA's and 29 WIA's. I guess you can say I am tired of being here and can't wait to get home. I do believe we are doing a good thing for the Lebanese people but I wish there was a better way to do it

Nov. 3, 1983-Unanswered letter to President Reagan from Matt Hukill, Maury's Brother:

Although we are deeply hurt by his (Maury's) loss, we are equally proud that he served our country to protect the freedom we all too often take for granted. I truly believe that our presence in Lebanon is warranted and necessary to stabilize that region of the world and protect America's future. We have never before, and hopefully never will, give in to this type of terrorist action against our country. However, as I reflect on the occurrences in Lebanon over the past year, I must say that I am deeply disappointed in the security measures taken to protect our men. ... If our objective is to protect the freedom and well-being of our countrymen, then why would we afford those men carrying out this duty less than adequate security? The safety and well-being of our servicemen abroad at any cost is absolutely necessary to achieve our country's objectives.

KIA Beirut Vet Honored in N.Y.

"We thought that we were attending a groundbreaking service, but Adam Ochs of the Vista N.Y. volunteer fire department moved mountains to get these Memorials done in time for 9/11/2012," said Mary Ellen Jackowski, mother of Beirut Veteran James J. Jackowski. The monument for her son and the 240 other Peacekeepers KIA in the terrorist bombing of the Marine barracks in Beirut on 23 Oct 1983 was originally dedicated in 1988 in South Salem NY. It was moved, blessed and rededicated on 9/11/2012, along with a beam from the WTC to honor the heroic firemen killed on 9/11/2001. Jamie's monument is situated at the beginning of the pathway to the 9/11 Memorial. "It was greatifying for pathway to the state full circle." Morrow gratifying for us since it brought this full-circle," Mary Elle wrote. "John Chipura, USMC, came home from Beirut after the terrorist bombing that killed our son Jamie and 240 US servicemen. He joined the NYPD and was promoted to Detective before he decided to join the FDNY. John was one of the 343 Firefighters killed on 9/11/2001 at the WTC. Having Jamie's monument and the beam from the WTC on 9/11 in the same area places Jamie and John together again."

Change to BVA Spirit Wear Sales

Sgt. Grit Agrees to Carry BVA items, Percentage of Sales Back to BVA

The BVA has changed how it sells spirit wear and related items.

Long-time volunteer spirit wear coordinator Cliff Walling has been called to the ministry, thus having to step down from the job he has done for decades.

"We will no longer be selling spirit wear from our web site," wrote BVA President Craig Renshaw in an email to members. "The BVA has for several years looked for someone to take over the position of sales, stocking and mailing of our Spirit wear and after some thought and consideration decided to contact Don at Sgt. Grit."

Sgt Grit is a web-based business run by a Vietnam veteran. The site offers arguably one of the widest selections of Marine Corps memorabilia anywhere. Their website and accompanying catalog boasts "If we don't have it, Chesty wouldn't want it." The website is found at www.grunt.com.

Renshaw said that a partnership has been formed with Sgt. Grit.

"We have agreed to work together to make this the best opportunity for our members to be able to buy their BVA spirit wear and other items," he wrote. "We ask that you give us time to work things out and to come up with new items and or designs."

The partnership, approved by the BVA Board of Directors, should be beneficial for everyone.

Not only will the BVA still be able to offer existing t-shirts, ball caps, golf shirts and other items, there are hopes to expand the line. "I ask and need you to send me any ideas you may have add to



our inventory," said Renshaw. "Most importantly I ask that you log onto www.grunt.com and sign in, to become a registered member of Sgt Grit."

He cites two reasons: so that members can be added to the Sgt. Grit email list to receive their newsletters and sales notices (they will from time to time list BVA items at lower cost); and also Sgt. Grit needs to know who is a member of the BVA so that when orders are placed by members, the BVA will receive a percentage of the sales of those items sold.

If, after login onto the site, you want to find items of interest to the BVA, just type "Beirut" in the search box and it will take you to BVA items.

For those who may not be familiar with Sgt. Grit, it is a web-based business that also has a store located in Oklahoma City. As Don, the owner, explains, "I hope this works out for all of us. I know the sell price of some items we were selling has gone up, but because of this agreement and in order to continue to have items to sell to our members this is what had to be done."
